- GPLU, 70% PES (recycled) 30% CO (organic), 240 g/m² in colour Medieval Blue, Cloudburst or Caviar Black
- FPLA, 65% PES 35% CO, 200 g/m² in colour Medieval Blue, Cloudburst or Caviar Black.

Reinforcement and knee pocket material is woven fabric ADKN, Cordura, 100% PA, 220 g/m² in colour Caviar Black, Maritime Blue or Turbulence.
